








MONO COUNTY CASES BY REGION



As of January 11, 2020




Total Positive Cases for Mono County Residents (last 30 d...

TESTED – 232 POSITIVE – 50* POSITIVITY RATE – 21.6% Test Results by Day (last 7 days)



REGIONAL STAY-AT-HOME ORDER



- Southern California remains under Stay-at-Home order; four-week ICU capacity projections do not meet criteria to exit order.
- Effective <u>Sunday, December 6 at 11:59 p.m.</u>, Mono County (as part of the Southern California Region) was formally placed under the California Department of Public Health (CDPH) *Regional Stay-At-Home Order*.
- The Order will be lifted when regional available adult ICU bed capacity is greater than or equal to 15% and is projected to remain above that level for the subsequent four weeks.
- At the end of the Stay-At-Home period, each county within the Region will be assigned to a tier based on the Blueprint for a Safer Economy.

REGIONAL STAY-AT-HOME ORDER



Southern California* (Mono County) Current ICU Capacity: 0.0%

- ICU capacity projections for regions that are eligible to exit the order are calculated daily based on four factors:
 - 1. Current estimated regional ICU capacity available
 - 2. Measure of current community transmission
 - 3. Current regional case rates, and
 - 4. Proportion of ICU cases being admitted
- Decreasing community transmission and increasing the health system capacity can help a region's projected ICU capacity so they can exit the order.

MONO COUNTY COVID-19 VACCINE UPDATE

- Safe and effective COVID-19 vaccines will be essential tools to end the global COVID-19 pandemic.
- Mammoth Hospital has received 720 doses of Pfizer vaccine
- Mono County Public Health has received 900 doses of Moderna vaccine (400 administered)
- Mono County Public Health expected to receive 2,925 doses late this week
- Vaccines are FREE and are voluntary
- Mono County will follow federal and state guidance for vaccine prioritization.
- Phase 1a-1c immunization timeline: **December Spring 2021**
- Phase 2-3: Spring Fall, 2021

Please complete the following confidential questionnaire in order to assist the Mono County Public Health Department prioritize COVID-19 immunizations per the Center for Disease Control (CDC) and California Department of Public Health (CDPH) guidelines.

Once the questionnaire is submitted, you will receive an email from the Public Health Department at the appointed time to register for your vaccination appointment(s) based on several factors, including availability of vaccine and the vaccination schedule outlined in detail below. Please be prepared to self-attest to the information provided to the Public Health Department at your vaccination appointment.

Vaccinate Mono

Phase 1a – Tier 1 (Almost complete)

- Acute care, psychiatric and correctional facility hospitals
- Skilled nursing facilities, assisted living facilities, and similar settings for older or medically vulnerable individuals
- Paramedics, EMTs and others providing emergency medical services





- Phase 1a Tier 2 (Almost complete)
 - Intermediate care facilities for persons who need non-continuous nursing supervision and supportive care
 - Home health care and in-home supportive services
 - Community health workers, including promotoras
 - Public health field staff
 - Primary Care clinics, including Federally Qualified Health Centers, Rural Health Centers,
 - Correctional facility clinics, and urgent care clinics

• Phase 1a – Tier 3 (Almost complete)

- Specialty clinics
- Laboratory workers
- Dental and other oral health clinics
- Pharmacy staff not working in settings at higher tiers



Phase 1b – Tier One (Up next...)

- People aged 75 years and older
- Food and agriculture (grocery store, restaurant, and agriculture workers)
- Education and childcare
- Emergency Services (non-medical first responders Law Enforcement, Fire; Search & Rescue, Ski Patrol)

Phase 1b – Tier Two

- People aged 65 to 74 years
- Incarcerated individuals (jails and prisons)
- Homeless/Unhoused
- Transportation and logistics (all people who drive or fly people/passengers)
- Industrial, residential and commercial (TBC)
- Critical manufacturing (N/A in Mono County)

Phase 1c - Tier One

- People aged 50-64 years
- People aged 16-49 years with underlying medical conditions which increase the risk of serious, life-threatening complications from COVID-19.
- Water and waste management, defense energy, chemical and hazardous, communications and IT and financial services
- Government Operations and Community Services

Phase 2-3 (Spring – Fall 2021)

- All remaining populations
- Workers in industries and occupations important to the functioning of society and at increased risk of exposure not included in Phases 1a, 1b and 1c
