Discussion:

The Mono County Assessment Appeals Board (AAB) is a quasi-judicial body consisting of impartial persons, who hear evidence from both parties before deciding upon the value of the property in question. The intent is to provide Taxpayers with a venue independent of the Assessor's Office to have their Assessment reviewed. In addition to understanding California's system of property taxation, AAB members are expected to understand the County's real estate markets and general appraisal principles and approaches to value. There are typically 8-10 meetings per year.

The AAB consists of three regular members and two alternate members. Generally, members serve a term of three (3) years; however, members appointed to vacancies will serve out the remainder of the vacant terms and may be reappointed.

Two Regular members and one Alternate member's terms will be ending September 1, 2024. The AAB met on July 15, 2024 to approve the recommendation to the Mono County Board of Supervisors to appoint the following as Regular and/or Alternate members of the Assessment Appeals Board, for terms ending September 1, 2027:

Crisis Care Mobile Units (CCMU) Grant Stipend for Crisis Team Members

DISCUSSION:

Mono County Behavioral Health (MCBH) received the CCMU grant in October 2021. Since that time, crisis team members have responded to 60+ mobile crisis calls, and 125 non-mobile crisis calls. Across the state, agencies report that recruitment and retention of crisis team members is incredibly difficult due to the nature of crisis response work. In an effort to reduce burn-out and retain the hard-working crisis team members MCBH currently has employed, MCBH would like to utilize the remaining "direct service funds" from the grant to offer stipends to crisis team members for shifts completed in FY 23/24 and again in FY 24/25. This expenditure has been approved by the grant administrator, the Union, and Mono County HR.

Every night, weekend, and holiday of the year, Behavioral Health has one primary, and one back up staff member on-call for crisis. The crisis team consists of 13 staff. The crisis team rotates on-call shifts throughout the year. Each team member provides 3-7 of these shifts each year. If staff receive a call during these shifts, they will respond immediately and must remain available until the crisis is resolved. This can take hours or days depending on the circumstances.

Attached on page 2 is a breakdown of stipend amounts per person based on number of on-call shifts assigned during FY 23/24.

I am writing on behalf of the 13,195 residents in Mono to urge you to include strong overall funding at or above Fiscal Year (FY) 2024 levels for the U.S. Department of Agriculture's Rural Development (USDA-RD) Programs in the final FY 2025 Agriculture, Rural Development, Food and Drug Administration and Related Agencies Appropriations bill. USDA-RD Programs are vital community building blocks critical to the livelihoods of millions of rural Americans.

Since the inception of USDA-RD, the agency has expanded essential services to tens of thousands of small communities and rural areas through grants, direct loans and loan guarantees. Every dollar from these programs has gone directly to rural customers, significantly improving quality of life, economic prosperity and public health in the 70 percent of the nation's counties considered rural with populations below 50,000 residents.

USDA-RD resources and personnel are indispensable to our shared mission to foster stronger, more resilient rural communities. In most rural counties, USDA-RD direct and guaranteed loan programs are the only affordable financing source for critical community infrastructure, housing and economic development.

In turn, the expertise of the USDA-RD's field staff in over 450 offices across the country, coupled with effective underwriting and technical assistance, has generated tangible successful results for rural America. Additional financial resources would help grow USDA-RD staff capacity and expand existing loan and grant programs to reach additional rural communities and more residents.

Mono County is no different. Since 2011, USDA-RD programs have invested \$29.7M in projects in my county. This includes business programs, community facilities, and single family housing.

The FY 2024 appropriations included \$22.3 billion in total discretionary funding authority for USDA, \$383 million below FY 2023 funding levels. These reduced funding levels included steep cuts to USDA-RD programs vital to county governments and residents. Without strong funding levels for USDA-RD programs at or above FY 2023 totals, counties like mine will be hard-pressed to deliver the essential services on which our residents and visitors rely.

Your support for restoring and maintaining funding for USDA-RD programs is essential to the prosperity of rural communities across the United States. I look forward to working with you to ensure strong funding for these programs in the FY 2025 Agriculture, Rural Development, Food and Drug Administration and Related Agencies Appropriations Bill.

Re: Wildlife Crossing Project and Prospective Grant Application

BACKGROUND

In 2016, Caltrans District 9 conducted a Feasibility Study Report on potential wildlife crossing locations on US 395 utilizing roadkill data, GPS trackers, and wildlife cameras. The study identified five hot spot locations, including Convict Creek, McGee area, Hot Creek Road, Mammoth Complex, and Mammoth Creek, that were consequently integrated into five project design concepts for wildlife crossing facilities. After the study's completion, Caltrans District 9 founded the multi-jurisdictional Eastern Sierra Wildlife Stewardship Team to inform project development. Alongside the newly formed team, Caltrans District 9 completed the Scoping Phase for the project in 2020 and finalized both the Project Study Report (PSR) and Project Initiation Document (PID). In 2021, Caltrans District 9 received a funding award from the California Wildlife Conservation Board (WCB) to complete CEQA/NEPA requirements for the project, which is currently underway.

Caltrans District 9 received a request from Supervisor Salcido, who participates on the Eastern Sierra Wildlife Stewardship Team, for a presentation on the project to the Board of Supervisors.

DISCUSSION

Next steps for the project include the development of Plans, Specifications, and Estimates (PS&E) and to secure funding for construction. Caltrans District 9 identified the Wildlife Crossing Pilot Program (WCPP) as a potential PS&E funding source, but the grant requires a 20% match which is expected to be fundraised from non-profit partners. Caltrans cannot accept this third-party match money and therefore cannot manage the grant or be the lead applicant.

Caltrans approached the Community Development Department as the potential applicant and, consistent with Mono County's Regional Transportation Plan (RTP) and General Plan policies supporting wildlife crossings (see below), the CDD is willing to serve as the applicant in coordination with Caltrans and other partners. The grant application is due on September 4, 2024. Grant program information is available at https://highways.dot.gov/federal-lands/wildlife-crossings/pilot-program.

The following Mono County adopted policies support reduction of wildlife collisions and direct staff to seek funding:

Regional Transportation Plan & Mono County General Plan Circulation Element

Policy 9.B. Reduce the potential for wildlife collisions to improve transportation system safety.

Objective 9.B.7. Seek funding for overpasses or undercrossing passageways for mule deer where highways intersect traditional migratory routes to reduce collisions and animal mortality.























Percentage of Recorded WVC's (N = 872) By Species U.S. Hwy 395, Mono County (2015-2020)






DISTRICT 9 TOTAL WILDLIFE MORTALITY BY COUNTY 2002-2020

Total Deer Mortality Within Caltrans Right of Way= 2,881




MONO CO TOTAL DEER MORTALITY BY ROUTE 2002-2020




US 395 MONO CO TOTAL DEER MORTALITY BY YEAR 2002-2020



Number of Deer-Vehicle Collisions (N= 790) U.S. Highway 395 (PM 01 - PM 120) Mono County, CA (2015-2020)









Mule Deer Migration in the Eastern Sierra





Discussion

On August 6, the Board voted unanimously to place a measure on the November 5, 2024 general that asks voters whether the transient occupancy tax ("TOT") rate in unincorporated Mono County shall be raised from 12% to 15% in order to generate an additional \$1.1 million annually in general fund revenues. The County Elections Official, the Mono County Clerk-Recorder, has designated the measure as Measure K.

While official advocacy for a county ballot measure is generally prohibited, there is a notable carve-out: Pursuant to Elections Code section 9162(a), the Board of Supervisors may file a written argument for or against any county measure. The argument may not exceed 300 words in length. The Mono County Elections Official has set today, August 20, 2024, as the deadline for submission of arguments in favor of or in opposition to any ballot measure. Submission of a written argument is not required, but it is the only advocacy opportunity for members of the Board in their official capacity as supervisors.

In consultation with the same consultants who previously assisted in drafting Measure K and in conducting polling on the proposed measure, staff has drafted a written argument in favor of Measure K for the Board to submit to the County Elections Official, attached to the resolution in the agenda packet as Exhibit A. The written argument emphasizes the priorities and concerns of the Board expressed at the July 9 and August 6 meetings when considering the measure to

increase the TOT, particularly the Board's commitment to allocating the increased general fund revenues to affordable and workforce housing.

The resolution presented to the Board authorizes transmission of the written argument in support of Measure K to the County Elections Official for inclusion in the county voter information guide. If the Board wishes to submit the argument, each individual Board member will sign the argument prior to submission to comply with the requirements of Elections Code section 9164.

Mono County faces a critical shortage of affordable and workforce housing. 


Voter Turnout in Mono County



Reality: You can vote for as many or as few contests as you choose.

Rumor: If I leave something blank on my ballot, my ballot will not be counted.

Facts: A blank contest on a ballot is known as an undervote. An undervote occurs when a voter intentionally or unintentionally does not vote in a specific contest. Properly marked votes on the ballot will then be counted. Democracy happens one contest at a time and every vote matters.

California Trusted Information

Reality: Voting rights are restored after a jail sentence is served.

Rumor: Californians with a felony background are prohibited from voting in the state's election.

Facts: A person with a criminal history can register to vote if the following applies: if they are on parole, probation, mandatory supervision, under post-release community supervision, federal supervised release, or in a local detention facility. A person with a criminal history cannot vote if they are <u>currently serving</u> a state or federal prison term for the conviction of a felony. Once the prisoner is released, their right to vote is automatically restored and they should visit <u>RegisterToVote.ca.gov</u> or fill out a paper registration form to register to vote.

Ballots shall be retrieved from drop boxes in teams of two at times determined by the elections official, but shall be subject to the following: Ballots shall be retrieved from drop boxes at least every 96 hours, excluding Saturdays and Sundays, between the 29th day before the election and the 10th day before an election. Ballots shall be retrieved from drop boxes every 48 hours, excluding Saturdays and Sundays, hours after the 10th day prior to an election through the closing of the polls on Election Day. Q3: Where are drop boxes located in Mono County?	A3: Look up drop box locations in Mono County HERE. Note: Ballots can be dropped off in any drop box in the State of California by 8:00 PM on Election Day.
Q4: I never received my ballot / I lost my ballot. Can you issue me a new one?	A4: Yes! You can call our office or email us to request a replacement ballot. You can also complete and return a Replacement Vote-by-Mail Ballot Application to our office in person, by mail, email, or fax.
Q5: When is the last day you can mail me a new ballot?	A5: The last day we can mail you a new ballot is October 29. After that date, you will need to come to our office in Bridgeport or go to your polling place on Election Day to be issued a new ballot.
Q6: Can you email me a ballot?	A6: Yes! We can email you a ballot up until Election Day. A Remote Accessible Vote-By-Mail (RAVBM) Ballot is emailed to you to download, mark selections, print, fill out and sign, and mail back to our office to be counted.
Q7: Can I track my ballot?	A7: Yes! The California Secretary of State is now offering Where's My Ballot? — a way for voters to track and receive notifications on the status of their vote-by-mail ballot.



Mono County is considering adopting an ordinance to prohibit smoking in multi-unit housing. The ordinance would apply only in the unincorporated areas of the County. There are a range of policy choices to consider when designing a local ordinance limiting smoking and vaping of substances in indoor and outdoor areas.

On November 21, 2023, the Mono County Board of Supervisors appointed Supervisor Kreitz and Supervisor Salcido to the Board of Supervisors Ad Hoc Smoke-free Multi Unit Housing Committee to help shape a proposed ordinance to be brought back to the full Board for consideration. Policymaker input is essential to ensure that a smoke-free multi-unit housing policy is well-crafted, legally sound, and aligned with the interests and needs of the unincorporated Mono County community.

The Board will hear a report out from the Ad Hoc Committee and Health and Human Services staff on progress to date towards drafting a proposed ordinance, including the outcome of survey outreach conducted in the unincorporated areas of Mono County.

Background

The California Indoor Clean Air Act of 1976 declares tobacco smoke as a health hazard for the general public. The United States Surgeon General has concluded that eliminating smoking in indoor spaces is the only way to fully protect non-smokers from secondhand smoke exposure and that separating smokers from non-smokers, cleaning the air, and ventilating buildings cannot completely prevent secondhand smoke exposure.

There are numerous policies in California and Mono County protecting people from secondhand smoke. However, there are no policies protecting residents from secondhand smoke in their homes. Secondhand smoke exposure threatens health, safety, and quality of life for children, adults, and animals. Secondhand smoke can migrate from other units and common areas and travel through doorways, cracks in walls, electrical lines, plumbing, and ventilation systems. Public and private multi-unit housing properties across the country have moved to solve this problem by making their housing, including individual units, smokefree. This not only protects residents and staff from exposure to secondhand smoke, but also saves properties money on costs to turnover units and significantly reduces fire risk for buildings.

County of Mono Smoke-Free Multi-Unit Housing Policy Development Temporary Ad Hoc Committee Charter / Scope of Work (Board Report – Attachment 1)

Background

Mono County Public Health's Tobacco Education Program has an objective to reduce exposure to secondhand smoke inside multi-unit housing units and in common areas. One evidence-based method to do this is through a smoke-free multi-unit housing policy. Public Health staff are currently engaging in community outreach to multi-unit residents and property owners in unincorporated Mono County who would be affected by such a policy. The formation of an Ad Hoc committee is requested to provide staff direction to help shape a draft ordinance to be brought back to the full Board for consideration.

Purpose and Scope

Given the myriad of policy choices, staff need input from Board of Supervisors members to propose a smoke-free multi-unit housing ordinance for consideration by the full Board.

Committee Duration

The duration of Committee involvement is estimated to be from December 2024 to October 2025.






Key Overarching Impact Areas



Q12. Would you be in favor of a Mono County policy that prohibits smoking/vaping in all individual units and indoor spaces of multifamily housing?



Q5. Are you in favor of a Mono County policy that prohibits smoking/vaping in all individual units and indoor spaces of multi-unit housing?



Q7. Do you believe that breathing secondhand nicotine/tobacco smoke/vapor is harmful to people's health?



Q3. Do you believe that breathing secondhand nicotine/tobacco smoke/vapor is harmful to people's health?



Q9. Do you believe that breathing secondhand marijuana/cannabis smoke/vapor is harmful to people's health?



Q4. Do you believe that breathing secondhand marijuana/cannabis smoke/vapor is harmful to people's health?



While five Mono County communities had Fire Safe Councils (FSC) prior to the Wildfire Mitigation Coordinator (WMC) Program start in December 2022, a comprehensive review of the FSCs within Mono County in 2023 made it clear the requirements to create, maintain, and administer official FSCs have limited the uptake of such organizations in Mono County and blunted the effectiveness of many of the existing FSCs. As a result, critical, on-the-ground wildfire resiliency and prevention work has also been limited within Mono County communities and neighborhoods.

The Firewise USA program has many of the benefits of a FSC, but it is more accessible, inclusive, and supportive:

- Firewise is voluntary and non-regulatory, while still requiring communities and residents to take meaningful and sustained actions to attain and maintain the Firewise Community recognition.
- Firewise allows every resident within a Firewise Community boundary who wants to be involved a direct seat at the table, because there is a high (2,500) household limit for a Firewise Community boundary.
- Firewise has the support of the National Fire Protection Association and, as such, provides direct access to the latest in wildfire mitigation and prevention research.
- Firewise requires CalFire officials (or in the case of the county's only incorporated town, Mammoth Lakes Fire Department officials) to directly engage with each community pursuing the Firewise recognition program during the required Community Wildfire Risk Assessment (CWRA). Fire officials and local community members work together to do a street-by-street wildfire risk assessment of each community during the CWRA and we are finding that residents believe this process is very useful.
- Firewise provides a direct benefit in the form of reduced insurance rates from some providers.

- A Firewise designation can make the difference between a winning or a losing grant application, because grant sponsors often look for proof of a neighborhood or community's prior capacity to organize and commitment.
- Perhaps most critically, the Firewise program can provide on-the-ground wildfire resiliency/prevention deliverables, such as training residents how to best harden their homes to prevent wildfire ignitions, and how to best protect their property from wildfire.

Because of these reasons and more (see below), the WMC Program has been systematically introducing and supporting Mono County communities and groups in becoming Firewise, starting in early winter 2023 and continuing to the present day.

The response from local communities (and community neighborhoods or neighborhood groups, such as Mammoth Lakes-based HOAs) has been very positive, based on direct experience working with the groups/communities, and as evidenced by the number of local Mono County communities and groups that are now pursuing Firewise recognition.

A secondary benefit of the Firewise program is that it allows/prompts communities and residents to organize for a possible wildfire emergency at a granular level, house by house, property by property. This process can make residents and communities more capable of responding to any emergency, from wildfire to snow hazards to earthquakes, or even to a public health emergency, due to the organizational framework provided by the process of becoming Firewise. The process of becoming Firewise requires several 'resident leaders' to lead the process, including engaging directly with local fire officials during the application process. These same leaders, along with other community members who might be interested or capable, can become effective conduits of critical information within their communities during an emergency, and/or communicate critical community needs/status to incoming emergency responders.

The Firewise program in Mono County has also been immeasurably aided and expanded by the work and expertise provided by Beth Burnam, the CalFire-appointed regional Firewise advisor for Mono and Inyo counties. Burnam is a long-time second homeowner in Mono County and has been working with the WMC Program since early 2023, providing the program with the benefits of her several decades of training, experience, and contacts as a community organizer working on Firewise and other wildfire resilience programs in her other home in Southern California. She is a self-described 'full time volunteer,' and has put in countless hours in Mono County mentoring emerging Firewise Communities and guiding them through the required steps to become Firewise. The partnership with Burnam is a critical component of the Firewise program's success in Mono County.



What is Firewise USA?

The national Firewise USA recognition program provides a collaborative framework to help neighbors in a geographic area get organized, find direction, and take action to increase the ignition resistance of their homes and community and to reduce wildfire risks at the local level.

Any community that meets a set of voluntary criteria on an annual basis and retains an "In Good Standing Status" may identify itself as being a Firewise Site.

The Firewise USA program is administered by National Fire Protection Association (NFPA®) and is co-sponsored by the USDA Forest Service and the National Association of State Foresters. While the NFPA administers this program, individuals and communities participate on a voluntary basis

Why is Firewise a good fit for Mono County?

- Firewise allows for more individual participation than the more familiar Fire Safe Councils because Firewise communities can be as large as 2,500 dwelling units (although CalFire is now capping units at 500).
- Unlike FSCs, Firewise communities are not required to become formal non-profits; this removes an administrative burden that many local FSCs were floundering under.
- The Firewise process requires CalFire to attend and work with each unincorporated community to complete a Community Wildfire Risk Assessment (CWRA), triggering a partnership model that has been mostly absent up to this point. In the case of Mammoth Lakes, the CWRA will be done by the Mammoth Lakes Fire Department.
- Prevention of a wildfire near or in a community is the best possible wildfire mitigation technique. The on-the-ground effort required to become and sustain Firewise recognition focuses on pragmatic, accessible wildfire prevention and mitigation techniques.
- Homeowners who live in Firewise Communities can get a discount on their FAIR Plan insurance.



Does it work?

- Given insurance discounts are still relatively low and given the amount of work it takes for a community to become Firewise, the logical question is does Firewise actually work to mitigate the effects of a wildfire on a community?
- The research into this subject is still in its infancy but there are clear signs the Firewise program is valued by those who know wildfire best; firefighters.
- As noted in the Staff Report, in a 2014 study by
 Headwaters Economics in the Journal of Forestry, they said
 "One recent qualitative study documents the impacts of
 wildfire preparedness on wildfire outcomes. The study
 reviewed senior-level wildfire managers about the
 potential of the Firewise Program to alter risks to
 structures, wildfire safety and suppression costs. Type I and
 Type II Incident Commanders were interviewed and found
 to have wide-spread agreement regarding the value of
 community-based wildfire programs such as Firewise..."

How does a community become recognized as Firewise?

Becoming recognized as a Firewise Community has 4 main steps:

- **Organize It**: Create a group of resident leaders that can commit to the typical six-month Firewise formation process.
- **Plan It:** Do a Community Wildfire Risk Assessment and a Three-Year Action Plan, more
- **Do It**: Do a community education event. Document any wildfire mitigation work already done
- Apply: Apply for recognition as a Firewise Community (document the above processes. Submit application to the NFPA.

How did we get here?





Let us count the ways...

Here is a photo of Bridgeport Fire Chief Nick Way at the home of Twin Lakes Estates residents Pat and Ginny Cates.

The Cates initially approached us during a September 2023 Firewise and Home Hardening Workshop at the Memorial Hall in Bridgeport.

During the winter of 2023-24, we worked with Pat and Ginny to increase their Twin Lakes Estates Property Owners Association (POA) interest in Firewise.

This meeting was on May 1, 2024, where Chief Way attended a Firewise meeting for the first time.

By the end of the two-hour meeting, he gave the Firewise program his support.



Every community has a unique path

A different process was followed by the Wheeler Crest Fire Safe Council.

The WCFSC was the highest functioning of all the county's FSC, due to a robust program of previous wildfire mitigation work and the tragic Round Fire. Because of this, the group took to Firewise like a duck to water.

By December 2023, they were ready to do the required Community Wildfire Risk Assessment (CWRA), meeting with CalFire officials. We piled into the CalFire vehicles and drove every street in Swall Meadows, then met at the Wheeler Crest Fire station the same day to complete the CWRA form, using CalFire's input and guidance.

In April 2024, Swall Meadows became the county's first ever official Firewise Community!



Future Firewise Community goals?

- A least one recognized Firewise Community in every unincorporated community and/or tribe/tribal group in the county.
- Firewise recognition for as many Mammoth Lakes HOAs as possible.
- Firewise Community recognition for as many Mammoth Lakes neighborhoods as possible. For example, an Old Mammoth Firewise Community, a Sierra Valley Estates Firewise Community, etc., could be options.



Other WMC Program updates

While the focus of this talk is on local Firewise Community status and development, we also want to highlight some other work we have been doing:

Five Mono County groups recently received a \$5,000 'mini grant' each to do wildfire mitigation work, for a total of \$25,000. The program, offered by SCE and administered by Whitebark Institute, was a success in Mono County, with all the groups that applied receiving the award.

The grant application process was unusually simple and brief and puts the grant money directly into local hands, with no middleman required.

All of these factors are helping to change the sense of futility many groups have about applying for grants, and we cannot thank SCE and Whitebark enough. The program will start over again in January 2025 and we intend to apply for as many grants as possible.

The five groups are:

- Twin Lakes Estates POA
- Wheeler Crest FSC
- Mono City Fire Protection District
- Snowcreek HOA
- Bridgeport Fire Protection District







- Collaborating with Inyo County on a Firewise Communities GIS mapping project.
- Working with invested groups to create a regional and/or county-wide Fire Safe Council.
- Continuing support for the Wood Innovations grant and proposed bioenergy facility.
- Working with the Mono County Emergency Services Manager on wildfire insurance issues.



Upcoming projects

- Create a more active digital and social media presence for the WMC
 Program within the ReadyMono forum.
- Work with invested groups to create a living, ten-year, all-agency Mono and Inyo counties fuels and wildfire mitigation projects master list.
- Increase engagement and outreach to local tribes, Spanish-speaking communities.

- Approve a Pilot Mono County Bridge Program Give the County Administrative Officer sign off authority on up to \$500,000 for a home purchase for the Bridge Program. Give staff any additional direction for the pilot program.
- Direct Staff to complete the analysis of potential housing programs so that the Bridge program can be compared to other options before being implemented

Background & Discussion

Staff is currently working to complete a housing policy analysis and programs/projects that could be used to create more housing for our community. This policy analysis will be data driven and provide the Board with a way to evaluate programs and projects in order to assist in decision-making and investment of public funds. We anticipate that this process will be completed in late September or early October and will be a valuable tool for both the Board and the community. As a part of this process, staff has reached out to members of the public and community groups to understand the different communities within the County and their unique housing needs. Staff has also engaged with the Eastern Sierra Community Housing (ESCH) Discovery Partnership Committee and feedback from the Committee was shared with the Board on August 13, 2024, as a part of the Housing Policy Analysis discussion.

ESCH Discovery Partnership Committee has discussed developing and implementing a pilot project to create a County Bridge Program modeled after the Town of Mammoth Lakes (TOML) Bridge Program. This initiative would purchase available single-family homes or condominiums within the unincorporated county, place qualified families in

these homes, and sell them at a discounted price that they can afford. In exchange, a 55-year deed restriction would be placed on the property, keeping it affordable at the same Area Median Income (AMI) level if sold before the deed restriction expires.

The TOML Bridge Program averages a subsidy of around \$150,000 per deed-restricted unit. If the County's program achieves a similar average, utilizing funds from the Local Housing Trust Fund and the Affordable Housing Fund, we could deed-restrict approximately six units.

Program Adaptation to the County:

Adapting this program to the County presents unique challenges. TOML has the advantage of purchasing condo units, which simplifies long-term upkeep. Condo associations handle external maintenance, reducing the likelihood of emergencies such as heating failures in winter or infrastructure issues common in single-family homes with well water and septic systems. The County faces greater complexity with over a dozen different infrastructure systems, compared to TOML's single system, making operations for a County Bridge Program less predictable.

Key Questions for Pilot Program Implementation:

1. How will we choose a property?

As of August 14, 2024, staff has identified 51 homes for sale in the unincorporated county, which is too many for in-depth evaluation of each property. One option is to work with a local realtor to narrow the selection to "turnkey" homes requiring minimal repairs. Once we identify potential homes, we need to avoid hidden problems. This would require either utilizing Public Works staff or hiring a private home inspector to conduct inspections, avoiding costly "Money Pit" scenarios. Recent home inspections, such as the Bridgeport purchase, cost approximately \$1,700, though prices vary based on several factors including size, location, and utilities (well, septic, public utility district, or a combination). Additionally, to ensure we are paying a fair price, an appraisal (\$500 - \$1,000) may be necessary. Setting clear guidelines for walking away from hidden problems or overpriced properties is crucial to avoid unnecessary expenses and wasted time.

2. How will we find buvers?

Once a home is acquired and any necessary repairs or rehabilitation are underway, we need to find qualified buyers who meet our AMI requirements and can secure a loan large enough to make the purchase. One option is to collaborate with ESCH to leverage their existing list of potential buyers. We are currently exploring the possibility of compensating ESCH for each qualified applicant or finalized sale. We have reached out to ESCH for a service quote but have not yet received a response.

3. Rehabilitation:

Given the desire to move quickly, we will likely be unable to make high-return improvements like enhancing building insulation, which could lower utility bills. In some cases, utility costs exceed \$400 per month, which could have a significant impact on homeowners.

4. Monitoring

The County, or an entity such as ESCH, would need to conduct annual checks on homes in the Bridge Program to ensure compliance with deed restriction requirements. This process will require either internal staff time or funding to compensate ESCH or another entity to perform these checks on the County's behalf.

Funding the Bridge Program:

There are three primary financial considerations for the County:

- 1. **Subsidy Costs:** TOML's program averages a \$150,000 subsidy per unit.
- 2. **Acquisition/Holding Costs:** The County must set aside funding to allow acquisition of units and holding the units until we find a buyer. This could range from \$400K-\$600K per unit.
- 3. **County Funds at Risk:** The County must decide its willingness to use and risk funds for purchasing a home while awaiting a buyer. If only housing dollars are used, this will tie up a substantial portion of available funds, potentially slowing down the Bridge Program and other housing initiatives.

Preliminary Scoring of a Bridge Program (Based on Criteria Shared with the Board):

• Unit Production:

Each \$1,000,000 investment will net approximately six units (approx. \$150,000 subsidy per unit plus additional transaction expenses), representing 28% of the net housing need (21 units per year). The gross housing need in unincorporated Mono County is estimated at 34 units per year.

• Initial County Investment Per Unit:

\$150,000 subsidy per unit and up to \$500,000 per unit used to purchase/hold property. A pilot could involve up to two units (up to \$1,000,000 to purchase/hold properties). Once homes are sold any funds not left in the unit for subsidy would be returned to the housing program.

• Duration of Use as Affordable Workforce Housing:

At least 55 years, likely perpetual if the County maintains a revolving loan fund and is willing to rehabilitate homes between buyers.

• Administrative Burden:

Significant staff time will be required, involving multiple departments depending on the extent of external assistance.

• Geographic Equity:

A Bridge Program could be implemented countywide, offering equitable access across different areas.

• Annual Net Revenue Created:

None, or potentially negative. Deed restrictions can discourage homeowners from making significant improvements or maintaining their properties adequately, as there is little financial incentive upon sale. This increases the likelihood that rehabilitation will be needed when the home is eventually sold. If the County uses its revolving loan fund to purchase deed-restricted homes that have been on the market for a set period before the restrictions can be lifted, additional rehabilitation costs may be necessary when reselling these homes.

• Greenhouse Gas Emissions:

Rapid implementation would largely ignore this criterion, with limited opportunities for energy-saving improvements. Low-cost homes may be located farther from services, increasing transportation-related emissions.
