Draft Minutes

October 27, 2022 – 9 a.m.

1. CALL TO ORDER/PLEDGE OF ALLEGIANCE

Meeting called to order at 9:01 am and Supervisor Gardner lead the pledge of allegiance.

2. PUBLIC COMMENT: Items of public interest not listed on the agenda.

3. MINUTES: Review/approve draft minutes from July 28, 2022

Continue approval of July minutes to January 27th.

4. 9:00 a.m. AGENCY ROUNDTABLE: Agency planning issues and pending projects.

- Salcido- Finalizing budgets for Town of Mammoth Lakes and continuing to allocate money to housing. 81 Units in phase 1 will be complete and ready for move in by the fall of 2023.
- Starosta (BLM)- Work being done by the county at different hot springs in the area with help with public safety including parking, trail work, and roads. Reports of a pack of dog attacks around the shady rest area and along the Ormat pipeline. Alabama hills none-paid dispersed camping permit roll-out coming soon.
- Bech (Bridgeport RD) The Forest Service recently responded to the substantial amount of fire fuels in the area. More to come on specifics such as treatments, project area, and other associated activities. Prep work for prescribed burning in the district. Housing continues to be a priority. Almost fully staffed.
- Black (CDFW) Lots of new funding improvements to the hatcheries program which will allow new vehicles, new tanks, and new staff which will help the ability to stock for future years. Fish are currently being vaccinated.
- Downard (CalTrans) Clean California and Mono Lake guardrail project happening on the 395 along Mono Lake. Cleaning up project along the North shore shoulder project and smoke bear flat pavement project is ongoing with minimal delays. State route 190 is still closed due to the flash flood as it is still being cleaned up.
- Sugimura (Mono County) Active Transportation Plan ongoing in June Lake working on outreach. Working on converting solid waste operations from the current location to Pumice Valley. Current projects in Mono County- Campground in North Mono Basin, Resort with Yurts on the back side of Crowley, Chalfant Cell tower, and future Board of Forestry Fire Safe regulations. Prescriptive designs for ADU's are available for anyone on the county's website.
