3. Approval of Minutes from November 15, 2018 meeting.

4. Review responses to Memo requesting information on regional solid waste services.

Two responses were received, one from Mammoth Disposal and one from D&S Waste. Both parties provided an overview of their submittal. Each party fielded questions, mostly with regard to recycling strategies. Common grounds were identified, and an outline of future solid waste solutions was developed. It was agreed by consensus that this information would be presented to the Mono County Board of Supervisors.

- *The Town of Mammoth Lakes and Mammoth Disposal will maintain their sole franchise agreement.*
- *Mammoth Disposal will expand their current transfer station operations at the current site to handle municipal solid waste from Mammoth Lakes and potentially Unincorporated Mono County.*
- *Pumice Valley Landfill will expand operations to handle industrial materials such as: Construction and Demolition Waste / Tires / Inert Material / Green Waste / Treated Wood / Carpet / Mattresses / Household Hazardous Waste / White Goods / Automobiles / Trailer / E-waste / and metal.*
 - *Wood diversion and chipping operations will also occur at Pumice Valley.*
 - *Permitted tonnage acceptance will be modified to accommodate projected increase.*
 - *Sludge landfarming is not likely option for Pumice Valley however, opportunities for processing or transporting should remain open.*
 - *Organics diversion and processing will need to be developed.*
- *Transfer Station Operations will be run by a single entity for all six locations in Unincorporated Mono County*
 - *Municipal Solid Waste*
 - *One or more existing transfer stations may be expanded to accommodate long haul processes.*
 - *Long haul transfer will be the responsibility of operator.*
- *The dual franchise system should remain.*
 - *Curbside recycling needs to be expanded county-wide.*
 - *An organics collection system will need to be developed.*
- *Contract for regional services should be a 20-year Agreement.*
- *Mono County Facilities Waste Hauling contract should be combined with other services.*
