Reviewed conditions required for grading permits. In general, if a civil engineer is involved, a grading permit is required. Other general conditions requiring a grading permit:

>10,000 sq feet of land More than 200 cu yd of dirt (1,000 cu yd under the house) moved Slope greater than 5:1 in fill Cut slope greater than 2:1

Public Works reviews all Building permit application and then plans are verified to determine if a grading permit will be required, not based upon applicants' assertions.

All dirt work should be secured by straw waddles as outlined in the BMP Handbook.
